



GENERAL NOTES:

- 1) 1/2" MINIMUM SPACING BETWEEN ADJACENT TERMINALS AND BETWEEN TERMINALS AND GROUND MEASURED ON COIL SURFACE.
- 2) IDENTIFY ALL TERMINALS ON SIDE OF COIL.
- 3) NAMEPLATE TO BE OBTAINED FROM ALLEN-BRADLEY CO. OR SUPPLIER. STAMP NAMEPLATE WITH A-B PART NUMBER, PRIMARY AND SECONDARY VOLTAGES, FREQUENCY, AND KVA. UL RECOGNIZED "TYPE" DESIGNATION AND CSA "FILE NUMBER" MUST BE STAMPED BY EACH SUPPLIER ON THE NAMEPLATE. MOUNT NAMEPLATE ON TRANSFORMER TO BE READ FROM THE SECONDARY SIDE, AND CENTER NAMEPLATE ON CORE TO PROVIDE SPACE FOR FUSE LABEL.
- 4) FLAT BLACK FINISH OVER ENTIRE TRANSFORMER.
